- Introduction of Safe Sport -- Two incidents occurred last season that MCSL was not appropriately prepared to address with immediate responses.
 - We have two guest speakers tonight. Greg York, of the York Swim Club and USA Swimming Safe Sport Committee:
 - 80% of issues begin with social media outreach and someone looking for information
 - It is the Coaches, Officials, and Reps job to protect the children.
 - MCSL has introduced Safe Sport to help protect your swimmers.
 - o Mike O'Shaughnessy, PVS Safe Sport Chair.
 - We are all here for the kids and want to ensure everyone has a safe and happy summer
 - We need to implement policies, so Coaches, Reps, and Officials are not subject to situations and accusations.
 - Provide education to ensure actions on deck are appropriate and safe, and appropriate steps can be taken to intervene.
 - Ensure no inappropriate conduct or activities occurs between Coaches, Athletes, and Parents.
 - Ensure there is no bullying, inappropriate relationships or interactions between Coaches/Officials/Parents (parental conduct/coaches conduct) occurs.
