Colorado Start Systems Prices for 2015 and SSL Hours

To all,

I apologize for not making it to the April Meeting, I had something come up at the last minute.

If you have not done so already, have someone check out your starting system and make sure it is ready to go for the summer. If you need a new one, the prices are:

- Starter with long corded microphone - \$735 plus \$25 shipping (total \$760).
- Tripod for above - \$148 plus \$25 shipping (total \$173).
- Extension Speaker with 125 foot cord - \$160 plus \$20 shipping (total \$180).
- If you need a new charger or something else we can get that also.

If you need a new battery, those can be obtained locally at a battery store (like Batteries Plus or Battery Warehouse), take your old one in with you. Expect to pay around \$30 (I think),

I plan to order in late May so we have them before Time Trials. You will pay me after I have ordered the equipment, hopefully before I give it to you at the June Meeting.

For SSL hours this summer you need to send me a note with what (in general) the kids will be doing and an Acord copy of the pools Liability Insurance. See the MCSL Home Page (www.mcsl.org) and select SSL Information for 2015. This will take you to a page with general information and a link to the SSL form you should use (it is pre-filled in with our name). I will supply the tax number that you will need after you send me the required information.
