- Jim urges teams to find and test their starters. If a team needs a new one, prices from Colorado: Infinity Unit - \$760, Tripod - \$177, Extension Speaker - \$185. We plan on ordering starters right after the May meeting to be here before the June meeting. MCSL also can order chargers and mics. Carrying cases are best found at Home Depot.
- Liz asks teams to order B meet ribbons by filling in the .pdf from the MCSL website and emailing the order to awards@mcsl.org. Checks can be mailed or brought to the Team Rep meeting when picking up your order. PLEASE, make sure your team is represented at the May meeting to pick up your awards, handbooks and guides for the coming season.
- Kathy, subbing for Andrew, reminds teams to pay their dues. Teams will not get to take home their awards, etc., if you haven't paid the team dues. The Green Book is at the printer and will be ready for next month. It is also available right now on-line. Reminds teams about concession stand licenses, staffing and contracts, registration, and double-checking your team's officials.
