- d. A rule change for first-time referees went into effect last year. In order to be a referee in MCSL you must have been a certified stroke and turn judge for two years.
- e. USA Swimming officials may transfer their stroke and turn and starter certifications to MCSL. See the website for more information.

- a. MCSL is certified by MCPS to offer SSL hours. If you have students who earn SSL hours, email Jim Garner (ssl@mcsl.org) for approval. There is a form to complete that Jim will send you. Forms must be submitted by the end of the season.
