- Time to test your computers! If you need a copy of Meet Manager, contact Eric Smith ([automation@mcsl.org](mailto:automation@mcsl.org)) and arrange to pick up a USB drive with a copy of the software.
- Please do not change a swimmer's name in the system after the first swim. This causes lots of problems.
- Automation training will be held on Monday, June 2 via Zoom. See the website for details. See the videos on the website for lots of helpful information. We recommend you view these prior to the training session.
- Remember - this is your LAST CHANCE to update your team information.
- Make sure to get your division job information completed and returned to MCSL as soon as possible if you have not already done so. The form is available on the website.
